## CITY OF THROCKMORTON MEETING MINUTES June 13, 2017

 Mayor Will Carroll called the city council meeting to order at 7:00 p.m. with council members Corey Keeter, Ricky Escalon, Susie Oliver and Brad Bellah present. Council member Judy Jackson was absent. Also present was Melanie Gober-City Secretary. Invocation was given by Mayor Carroll.

3. There was no one present for Citizens Participation. Mayor Carroll reported: Mowing and street repairs are being done. The flood waters damaged streets, fences, buildings, the City Park, numerous trees and debride were washed/broken and will need to be cleaned up, and minimal damage was done to the Waste Water Treatment Plant. Our insurance has a \$25,000.00 deductible so the City will eat the cost of the repairs that will have to be done; Throckmorton County has been declared a disaster area. Mayor Carroll has filled out the Disaster Summary Form for the City of Throckmorton; this information will be sent to the Department of Transportation and eventually to the Governor's office. In the future, if there is any disaster relief funding awarded they will have the information for the City of Throckmorton; We will be spraying for mosquito's and will continue to use larvicides and non-invasive/non-chemical solutions to keep from having to spray with chemicals when possible. If we receive numerous calls from citizens complaining and requesting we spray with chemicals, we will do so, otherwise we will continue to do all we can to use non-invasive/non-chemical solutions as we've done in the past. We have some people that due to health reasons have requested we don't spray chemicals close to their residence. When the City does spray with chemicals these people are personally notified so they can avoid the area; Splash Day at the pool was held on June 1st, 2017 with no problems reported. The next day was when the flood came, there was no damage done to the pool itself but the flood water did get into the pool house. The disinfectant levels in the water was affected by the abundance of fresh water from the rain but after adding the appropriate chemicals the levels are fine and the pool was safe for swimming; The City was awarded a Tire Amnesty Grant through WCTCOG. A trailer was brought by Liberty Tire & Recycling and set up at the Convenience Station, the City workers loaded all the tires into it and the company came back and hauled them off with no cost to the City, this saved the City several thousand dollars; The Airport was closed for a short period of time for repairs due to flood water. It will be closed again Thursday through Saturday of this week for repairs which is part of the TX DOT RAMP Grant. Mayor Carroll will be attending a meeting tomorrow in Wichita Falls with TX DOT Aviation Division and Wichita Falls Region Road Division regarding repairs and updating of our Airport; there was a leak in the main water line at Pump Service & Supply this morning. It was repaired by the City workers. A Boil Water Notice was issued as required by TCEO due to low water pressure and will be rescinded as soon as the appropriate steps have been taken to insure the safety of the water; Corey Keeter asked if there is anything that can be done to clean out the creek? Mayor Carroll will inquire into the problem, find out if what can be done and report back at a later time.
