

**CITY OF THROCKMORTON  
MEETING MINUTES  
May 12, 2015**

1. Mayor Will Carroll called the city council meeting to order at 7:00 p.m. with council members Judy Jackson, Geneva Rodgers, Corey Keeter and Troy Batts present. Council member Tamra Gray was absent. Also present was Melanie Gober-City Secretary. Invocation was given by Troy Batts.
2. Council Members approved the minutes from the April 16, 2015 Regular Meeting.

6. The Council discussed and approved a 2.5% Cost of Living increase for all City employees that aren't under disciplinary action at this time. Any employee that is under disciplinary action at this time will be re-evaluated in 90 days.
