

**ORDINANCE NO. 2014-04**

**AN ORDINANCE ORDERING AND PROVIDING NOTICE OF A LOCAL OPTION ELECTION FOR THE CITY OF THROCKMORTON, TEXAS TO CONSIDER A PROPOSITION LEGALIZING THE SALE OF BEER AND WINE FOR OFF-PREMISE CONSUMPTION ONLY, TO BE HELD ON THE FOURTH DAY OF NOVEMBER, 2014 PROVIDING A LIST OF POLLING PLACES; PROVIDING FOR EARLY VOTING; PROVIDING FOR THE INCLUSION OF NEW TERRITORY, IF ANY; PROVIDING FOR THE POSTING AND PUBLICATION NOTICE; AND PROVIDING AN EFFECTIVE DATE.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF THROCKMORTON, TEXAS:**

**Section 1**

**ELECTION ORDER AND NOTICE OF ELECTION**

There is hereby ordered an election to be participated in by the qualified voters of the City of Throckmorton, Texas, to be held on the first Tuesday in November, 2014 being the 4<sup>th</sup> day of November, 2014, between the hours of 7:00 a.m. and 7:00 p.m., for the purpose of considering the following proposition, on which voters shall be entitled to vote either "For" or "Against":

"The legal sale of beer and wine for off-premise consumption only"

**Section 2**

**POLLING PLACES**

The polling places for the election shall be as shown on Exhibit "A", attached hereto and incorporated herein by reference.

**Section 3**

**EARLY VOTING**

Early voting by personal appearance shall be conducted at the County Clerk's Office, 121 N. Minter Ave, Throckmorton, Texas. Applications for ballot by mail shall be mailed to:

Early voting by personal appearance for the election as ordered by Section 1, above, shall be conducted on weekdays beginning on Monday, October 20<sup>th</sup>, 2014 through Friday, October 24<sup>th</sup>, 2014 between the hours of 8:00 a.m. and 5:00 p.m.; Monday, October 27<sup>th</sup>, 2014 through Friday, October 31<sup>st</sup>, 2014, between the hours of 8:00 a.m. and 5:00 p.m. Applications for ballots by mail for the election must be received no later than the close of business on October 24<sup>th</sup>, 2014.

**Section 4**

**NEW TERRITORY**

In all the territory annexed to the City of Throckmorton which is not included in an established district of the City of Throckmorton, the qualified voters therein may vote in the district contiguous thereto.

**Section 5**

**NOTICE OF ELECTION; PUBLICATION AND POSTING**

This election order shall constitute a notice of election and this notice shall be:


- (1) published at least once, not earlier than the 30<sup>th</sup> day or later than the 10<sup>th</sup> day before the election day, which publication shall include a complete listing of all polling places; and
- (2) posted on the bulletin board used for posting notices of the meeting of the City Council, which copy shall also include a complete listing of all polling places, not later than the 21<sup>st</sup> day before the election.
